



### ***Membership agreement terms and conditions***

***Monthly membership:*** you may cancel a monthly membership at any time by sending a written notice to Yoga Yoga at least 15 days prior to your next scheduled debit date. If you have signed up for the monthly unlimited auto renewal or the 15 class pass auto renewal, you must fulfill the 6 month contract agreement of all payments prior to cancellation. Upon receiving your cancellation written notice, Yoga Yoga will apply your last month membership dues and your membership will expire 30 days following your next scheduled debit date.

### ***Refunds***

Request for a refund of dues will not be honored for any time period in which your account shows attending of any of the Yoga Yoga regular classes.

### ***Rejoin***

If you cancel your membership and you want to rejoin, you must buy a new membership at the then prevailing rates.

### ***Payment Obligation***

Buyer shall not be relieved of his or her obligations to make payments agreed to, and no deduction from any payments shall be made because of any member's failure to come to classes.

### ***Automatic debit***

Your dues, unless prepaid, must be paid through credit card on the date designated in the agreement.

### ***Freeze Policy***

The freeze policy allow a member in good standing to temporarily suspend his or her membership once upon written notice to Yoga Yoga at least 15 days prior to your next scheduled billing date in accordance with the following terms: 1) once every 12 months;

2) for a minimum of 1 month and a maximum of 3 consecutive months. 3) The freeze must begin at the start of a billing cycle and can only be requested in monthly increments.

**6-Month Membership**

I understand that the term of my member agreement with Yoga Yoga is for a minimum of six (6) months. I further understand that after such initial six (6) month period, that the term of the Agreement shall automatically continue on a month-to-month basis and I may terminate the agreement in accordance within terms. I also understand that I should refer to the agreement of information about non-payment and default provisions

I understand that by signing the agreement. I am signing an installment sales contract. I understand that I am agreeing to pay \_\_\_\_\_per month.(\$95.00, \$150.00)

I will only be legally excused from paying Yoga Yoga with a 30 day written notice if I become disabled or move at least 50 miles or more from the current address on this agreement.

I understand that my membership entitles me with unlimited access to all regular scheduled classes.
